# Discovering the International Labour Organisation

The International Labour Organization (ILO) is a specialized agency of the United Nations that promotes social justice and promotes decent work opportunities for everyone.





#### History of the ILO

The ILO was founded in 1919, following the aftermath of World War I, to promote social justice and improve working conditions worldwide. Over 100 years later, the organization continues to work towards creating a fair and inclusive global economy.

#### (1)—The Founding Years

The ILO was born out of the Treaty of Versailles in 1919, and it established a unique tripartite structure involving governments, employers, and workers in decision-making.

#### (2)——Global Expansion

The ILO expanded its work to include the improvement of working conditions, including fighting against forced labor, child labor, and discrimination in the workplace.

#### (3)—The Present Day

Today, the ILO plays a vital role in global policy discussions and carries out important research and advocacy work towards achieving decent work for all.



- Health services are one of the fundamental sectors of society and the economy.
- The ILO endorses the fundamental principles of the human right to health and social security.
- Decent working conditions for health workers are essential to provide health services and to ensure that all members of society have access to social health protection.
- The lack of capacity to provide health services has significant effects on individual and public health, poverty, income generation, labour market productivity, economic growth and development.



## **Universal Health Coverage**

#### The ILO's Mission and Objectives

The ILO's mission is to promote social justice and promote decent work opportunities for everyone. The organization works towards ensuring that everyone has access to good-quality employment, social protection, and workers' rights, regardless of their background, education, or social status.

#### **Job Security**

The ILO seeks to create opportunities for secure employment, under conditions of freedom, equity, human dignity, and social protection.

#### Workers' Rights

The ILO is committed to promoting the recognition of workers' rights and protecting them from exploitation and discrimination.

#### **Equality**

The ILO promotes gender equality and the elimination of all forms of discrimination in the workplace.

- While the burden of disease and the demand for health services varies in each community, the affordability of health care challenges most countries.
- Therefore, many governments have considered or implemented wide-spread reforms of their health care systems, re-shaping the employment environment for health care workers.

- In addition to promoting social health protection
  for all workers, the ILO supports better working conditions
  for health workers through sectoral labour standards
  and social dialogue.
- The shortage of trained health workers coincides with longer life expectancies, increasing use of specialized medical technology and the rise of new and drug resistant diseases.

- Meanwhile, hospitals and other health facilities are rarely considered as workplaces.
- As the demand for health services grows and the shortage of qualified health personnel becomes more severe, working conditions deteriorate and the quality of health care may be jeopardised.

WHO/ILO Joint Estimates of the Work-related Burden of Disease and Injury, 2000–2016

- The critical shortage of workers in the poorest countries is further exacerbated by wealthier countries offering better working conditions to migrant health workers.
- ILO collaborates with WHO to address these challenges by recognizing health facilities as unique work environments and encouraging improvements of working conditions so that health workers are encouraged and supported to provide high quality care in their own communities.

## The Role of the ILO in Promoting Decent Work and Social Justice

The ILO plays a crucial role in promoting social justice and supporting decent work worldwide.

One example is their advocacy for green jobs, which can help create sustainable economic

growth while also preserving the environment.



**Green Jobs** 

The ILO supports policies that promote green jobs and help create a more sustainable future for workers and their families.



**Child Labor** 

The ILO is working to eliminate child labor worldwide, providing support for children and their families while also advocating for the ratification of international conventions.



**Decent Work** 

The ILO promotes the creation of decent and dignified employment opportunities for all, regardless of their gender, background, or social status.

#### **ILO Conventions and Standards**

The ILO has developed a set of international labor standards that promote social justice and help to create a more equal and sustainable world. These conventions cover a wide range of issues, including forced labor, child labor, and freedom of association.

Forced Labor Convention (1930)

The ILO works to eliminate all forms of forced labor, including modern-day slavery, debt bondage, and human trafficking.

Child Labor Convention (1973)

The ILO seeks to eradicated child labor worldwide and ensure that all children have access to education and a bright future.

Convention on the Rights of Persons with Disabilities (2006)

The ILO promotes the rights of people with disabilities and works to eliminate discrimination in the workplace and society as a whole.


